In Law on the Protection of Personal Data numbered 6698 (referred to as "KVKK"), personal data owners (referred to as "Applicant"), defined as "data subject", are granted the following rights under Article 11 of KVKK:

- To learn whether his/her personal data are processed or not,
- To demand for information as to if his/her personal data have been processed,
- To learn the purpose of the processing of his/her personal data and whether these personal data are used in compliance with the purpose,
- To know the third parties to whom his personal data are transferred in country or abroad,
- to request the rectification of the incomplete or inaccurate data, if any,
- To request the erasure or destruction of your personal data and notifying the third parties to whom the personal data has been transferred, if the reasons requiring processing are no longer valid, although it has been processed in accordance with the provisions of other laws and other legislation related to KVKK,
- To object to the occurrence of a result against you by analysing the processed data exclusively through automated systems,
- To claim compensation in case you have damage due to unlawful processing of your personal data.

Pursuant to the Communiqué on the Procedures and Principles of Application to the Data Controller, with paragraph 1 of Article 13 of the KVKK; Applications to be made to our Company regarding these rights are made in writing or by sending an e-mail to rasyonet@hs01.kep.tr via your e-mail address previously notified to our Company and using our Company's registered e-mail (rasyonet@hs01.kep.tr) address, or Personal Data Protection Authority (referred to as the "Board") by other methods to be determined in the future.
